Treasurer's Report: Gene A handed out and read Treasurer's report. Discussion of financial report. Motion made by Sherry, seconded by Dan and passed unanimously to accept reports.

### Committee Reports:

- Answering Service, Gene A: Pro-Tel charged us \$18.00 last month and \$26.50 for this month.
- Activities, LaVon L:
  - Discussed needs for Pacific Northwest Conference that will be held here (put on by Area 92) Friday, June 22 through Sunday, June 24.
  - LaVina anniversary will be held July 28 and 29 in Pasco. Continuous translation from Spanish to English will be provided.
